

DECLARATION FOR ENTRY INTO ITALY – FLIGHTS FROM THE U.K.

In consideration of the measures provided for by Prime Ministerial Decree dated 14/01/2021 (specifically Articles 6, 7, 8 and 9) issued in order to combat the spread of the "COVID-19" pandemic and by the Orders of the Ministry of Health dated 20/12/2020 and 09/01/2021, with which entry into the national territory and air traffic from the United Kingdom of Great Britain and Northern Ireland is limited and setting out that entry is permitted only according to the following regulations:

- a) obligation to show the airline, upon boarding, a certification of having undergone a molecular or antigenic test (swab) **within 72 hours prior to entry** into Italy;
- b) **obligation to undergo molecular or antigenic tests** (swab) upon arrival at the airport, or within 48 hours of entering Italy. For direct flights from the United Kingdom of Great Britain and Northern Ireland, the swab must be carried out exclusively at the airport;
- c) **obligation to undergo health surveillance and self-isolation for 14 days**, regardless of the outcome of the test.
- d) Only the molecular or antigen test (swab) is required for the crew of the aircraft and the travelling staff of the means of transport for people or goods, to be carried out upon arrival at the airport, that is, within 48 hours of entry into Italy without the need to undergo the period of self-isolation
